
ADOPTING FOR IMPLEMENTATION A STUDY GUIDE FOR STUDY OF IMPACTS OF AGRICULTURAL DISCHARGES AND OPERATIONS UPON AQUATIC AND WILDLIFE RESOURCES IN IRRIGATION DRAINS IN THE COLORADO RIVER BASIN REGION

- WHEREAS, this Regional Board's Water Quality Control Plans for the West and East Colorado River Basins (7A and 7B), authorizes "formation of an organization to develop and conduct studies to determine the actual aquatic and wildlife resources in the irrigation drains, and the unit benefits that may be achieved by controlling fertilizers and pesticides at various levels"; and
- WHEREAS, on January 29, 1976 this Board adopted Resolution No. 76-16, which established the Regional Agricultural Water Quality Advisory Committee to assist and advise the Regional Board and its Executive Officer on water quality matters pertaining to agriculture; and
- WHEREAS, the Regional Agricultural Water Quality Advisory Committee assisted the Executive Officer in the development of a "Study Guide for Study of Impacts of Agricultural Discharges and Operations Upon Aquatic and Wildlife Resources in Irrigation Drains in the Colorado River Basin Region" ("Study Guide"); and
- WHEREAS, the Regional Agricultural Water Quality Advisory Committee adopted Resolution No. A-77-1, which was signed by Committee Chairman Earl Harriss on December 20, 1976, and which recommends that the Regional Board adopt said "Study Guide" (Parts I through IV, dated January, 1977) for implementation; now, therefore be it
- RESOLVED, that this Regional Board:
1. Adopts for implementation the "Study Guide for Study of Impacts of Agricultural Discharges and Operations Upon Aquatic and Wildlife Resources in Irrigation Drains in the Colorado River Basin Region", dated January, 1977;
