ORDER NO. 78-83

RESCISSION OF WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Board, Colorado River Basin Region, finds that:

1. The below-listed Board Resolutions and Orders contain waste discharge requirements for waste discharge facilities that now have individual subsurface disposal systems, are no longer in use, were never constructed, are discharging subsurface with an average daily discharge that is currently below a maximum of 1500 gallons-per-day, are superseded by recently adopted Orders, have been connected to a community sewerage system, or the requirements pertain to the construction phase only.
2. The below-listed Board Resolutions and Orders ought to be rescinded.
3. The Board forwarded timely notices by mail to the dischargers for whom waste discharge requirements are prescribed in each of the below-listed Resolutions and Orders, explaining the Board's considerations of rescinding the particular Resolution and Order, and requesting timely comments.
4. The Board heard and considered all comments pertaining to the proposed rescinding of the below-listed Resolutions and Orders.


