RESOLVED, That the members of this Regional Board wish Kay Olesen the best of health and happiness in the future; and be it further


RESOLVED, That the members of this Regional Board extend a welcome to Kay Olesen to attend meetings of this Board whenever he may wish to do so; and be it further


