has made proof as of May 7, 1953,

(the date of inspection) to the satisfaction of the State Water Rights Board of a right to the use of the water of Franklin Creek sometimes called Swearer Creek in Modoc County tributary to North Fork Pit River.

for the purpose of irrigation, stockwatering and recreational uses.

under Permit 5445 of the State Water Rights Board and that said right to the use of said water has been perfected in accordance with the laws of California, the Rules and Regulations of the State Water Rights Board and the terms of the said permit; that the priority of the right herein confirmed dates from June 6, 1939, and that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to the amount actually beneficially used for said purposes and shall not exceed one hundred (100) acre-feet per annum to be collected from about November 15 of each year to about March 15 of the succeeding year. Maximum rate of diversion to storage is eight (8) cubic feet per second.

The point of diversion of such water is located north seventy-five degrees, thirty minutes east ($N75^{\circ} 30' E$), six hundred eighty (680) feet from $S\frac{1}{2}$ corner of Section 14, T44N, R14E, MDB&M, being within $SW\frac{1}{4}$ of $SE\frac{1}{4}$ of said Section 14.

The points of rediversion of such water are located as follows:

No. 22 (Wilson Main Diversion) North forty-one degrees west ($N41^{\circ} W$), three thousand one hundred fifty (3,150) feet from SE corner of Section 34, T44N, R14E, MDB&M being within $NW\frac{1}{4}$ of $SE\frac{1}{4}$ of said Section 34.

No. 23 (Wilson Lower Diversion) North fifty one degrees west ($N51^{\circ} W$), three thousand eight hundred (3,800) feet from SE corner of Section 34, T44N, R14E, MDB&M being within $NE\frac{1}{4}$ of $SW\frac{1}{4}$ of said Section 34.

No. 24 (Joseph Creek Diversion) South twenty-four degrees west ($S24^{\circ} W$), two thousand nine hundred fifty (2,950) feet from NE corner of Section 33, T44N, R14E, MDB&M, being within $NE\frac{1}{4}$ of $SE\frac{1}{4}$ of said Section 33.

No. 25 (Lower Joseph Creek Diversion) South seventy-three degrees west ($S73^{\circ} W$), five thousand hundred fifty (5,150) feet from NE corner of Section 33, T44N, R14E, MDB&M, being within $SW\frac{1}{4}$ of $NW\frac{1}{4}$ of Section 33.

No. 27 (School House Diversion) South fifty-one degrees west ($S51^{\circ} W$), two thousand three hundred (2,300) feet from NE corner of Section 32, T44N, R14E, MDB&M, being within $SW\frac{1}{4}$ of $NE\frac{1}{4}$ of said Section 32.

No. 28 (Black Upper Diversion) South six degrees east ($S6^{\circ} E$), one thousand five hundred (1,500) feet from NW corner of Section 32, T44N, R14E, MDB&M, being within $SW\frac{1}{4}$ of $NW\frac{1}{4}$ of said Section 32.

No. 29 (Black Middle Diversion) South forty-seven degrees west ($S47^{\circ} W$), one thousand six hundred feet from NE corner of Section 31, T44N, R14E, MDB&M being within $NE\frac{1}{4}$ of $NE\frac{1}{4}$ of said Section 31.

No. 30 (Black Lower Diversion) South seventy-seven degrees west ($S77^{\circ} W$), two thousand six hundred (2,600) feet from NE corner of Section 31, T44N, R14E, MDB&M, being within $NW\frac{1}{4}$ of $NE\frac{1}{4}$ of said Section 31.

A description of the lands or the place where such water is put to beneficial use is as follows:

6.2 ACRES WITHIN SECTION 28, T44N, R14E, MDB&M
78.2 ACRES WITHIN SECTION 29, T44N, R14E, MDB&M
64.0 ACRES WITHIN SECTION 30, T44N, R14E, MDB&M
64.0 ACRES WITHIN SECTION 31, T44N, R14E, MDB&M
100.8 ACRES WITHIN SECTION 32, T44N, R14E, MDB&M
86.8 ACRES WITHIN SECTION 33, T44N, R14E, MDB&M
400.0 ACRES TOTAL AS SHOWN ON MAP FILED WITH STATE WATER RIGHTS BOARD

All rights and privileges under this license including method of diversion, method of use and quantity of water diverted are subject to the continuing authority of the State Water Rights Board in accordance with law and in the interest of the public welfare to prevent waste, unreasonable use, unreasonable method of use or unreasonable method of diversion of said water.

Reports shall be filed promptly by licensee on appropriate forms which will be provided for the purpose from time to time by the State Water Rights Board.

The right hereby confirmed to the diversion and use of water is restricted to the point or points of diversion herein specified and to the lands or place of use herein described.

COVERED BY LICENSE ORDER NO. 4


This license is granted and licensee accepts all rights herein confirmed subject to the following provisions of the Water Code:

- Section 1625. Each license shall be in such form and contain such terms as may be prescribed by the board.
- Section 1626. All licenses shall be under the terms and conditions of this division (of the Water Code).
- Section 1627. A license shall be effective for such time as the water actually appropriated under it is used for a useful and beneficial purpose in conformity with this division (of the Water Code) but no longer.
- Section 1628. Every license shall include the enumeration of conditions therein which in substance shall include all of the provisions of this article and the statement that any appropriator of water to whom a license is issued takes the license subject to the conditions therein expressed.
- Section 1629. Every licensee, if he accepts a license does so under the conditions precedent that no value whatsoever in excess of the actual amount paid to the State therefor shall at any time be assigned to or claimed for any license granted or issued under the provisions of this division (of the Water Code), or for any rights granted or acquired under the provisions of this division (of the Water Code), in respect to the regulation by any competent public authority of the services or the price of the services to be rendered by any licensee or by the holder of any rights granted or acquired under the provisions of this division (of the Water Code) or in respect to any valuation for purposes of sale to or purchase, whether through condemnation proceedings or otherwise, by the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State, of the rights and property of any licensee, or the possessor of any rights granted, issued, or acquired under the provisions of this division (of the Water Code).
- Section 1630. At any time after the expiration of twenty years after the granting of a license, the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State shall have the right to purchase the works and property occupied and used under the license and the works built or constructed for the enjoyment of the rights granted under the license.
- Section 1631. In the event that the State, or any city, city and county, municipal water district, irrigation district, lighting district, or political subdivision of the State so desiring to purchase and the owner of the works and property cannot agree upon the purchase price, the price shall be determined in such manner as is now or may hereafter be provided by law for determining the value of property taken in eminent domain proceedings.
