License for Diversion and Use of Water

APPLICATION 14902PERMIT 9262LICENSE 4533

THIS IS TO CERTIFY, *That* United States - Eldorado National Forest
Placerville, California

has made proof as of June 17, 1954
(the date of inspection) to the satisfaction of the State Water Rights Board of a right to the use of the water of
Aspen Creek in El Dorado County

tributary to South Fork American River

for the purpose of domestic and fire protection use
under Permit 9262 of the State Water Rights Board and that said right to the use of said water has been
perfected in accordance with the laws of California, the Rules and Regulations of the State Water Rights Board and the
terms of the said permit; that the priority of the right herein confirmed dates from July 10, 1952;
and that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited
to the amount actually beneficially used for said purposes and shall not exceed four hundred fifty (450)
gallons per day for domestic purposes or five hundred fifty (550) gallons per day
total for domestic and fire protection purposes from about May 1 to about November 15
of each year, provided, however, that nothing herein contained shall be construed as
confirming in licensee any right, which shall be good as against a subsequent
appropriator, to an amount for fire protection purposes except when there exists
an actual need thereof for fire fighting use.

The point of diversion of such water is located south twenty-seven degrees thirty minutes west
(S 27° 30' W) two thousand sixty (2,060) feet from E $\frac{1}{4}$ corner of Section 10, T 11 N,
R 17 E, MDB&M, being within SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of said Section 10.

A description of the lands or the place where such water is put to beneficial use is as follows: Lots 13 and 14
of Aspen Creek Summer Home Tract of Eldorado National Forest, being within S $\frac{1}{2}$
of SE $\frac{1}{4}$ of Section 10, T 11 N, R 17 E, MDB&M.

All rights and privileges under this license including method of diversion, method of use and quantity of water
diverted are subject to the continuing authority of the State Water Rights Board in accordance with law and in the
interest of the public welfare to prevent waste, unreasonable use, unreasonable method of use or unreasonable method of
diversion of said water.

Reports shall be filed promptly by licensee on appropriate forms which will be provided for the purpose from time
to time by the State Water Rights Board.

The right hereby confirmed to the diversion and use of water is restricted to the point or points of diversion herein
specified and to the lands or place of use herein described.

This license is granted and licensee accepts all rights herein confirmed subject to the following provisions of the Water Code:

Section 1625. Each license shall be in such form and contain such terms as may be prescribed by the board.

Section 1626. All licenses shall be under the terms and conditions of this division (of the Water Code).

Section 1627. A license shall be effective for such time as the water actually appropriated under it is used for a useful and beneficial purpose in conformity with this division (of the Water Code) but no longer.

Section 1628. Every license shall include the enumeration of conditions therein which in substance shall include all of the provisions of this article and the statement that any appropriator of water to whom a license is issued takes the license subject to the conditions therein expressed.


Section 1629. Every licensee, if he accepts a license does so under the conditions precedent that no value whatsoever in excess of the actual amount paid to the State therefor shall at any time be assigned to or claimed for any license granted or issued under the provisions of this division (of the Water Code), or for any rights granted or acquired under the provisions of this division (of the Water Code), in respect to the regulation by any competent public authority of the services or the price of the services to be rendered by any licensee or by the holder of any rights granted or acquired under the provisions of this division (of the Water Code) or in respect to any valuation for purposes of sale to or purchase, whether through condemnation proceedings or otherwise, by the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State, of the rights and property of any licensee, or the possessor of any rights granted, issued, or acquired under the provisions of this division (of the Water Code).

Section 1630. At any time after the expiration of twenty years after the granting of a license, the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State shall have the right to purchase the works and property occupied and used under the license and the works built or constructed for the enjoyment of the rights granted under the license.

Section 1631. In the event that the State, or any city, city and county, municipal water district, irrigation district, lighting district, or political subdivision of the State so desiring to purchase and the owner of the works and property cannot agree upon the purchase price, the price shall be determined in such manner as is now or may hereafter be provided by law for determining the value of property taken in eminent domain proceedings.
