to the satisfaction of the State Water Resources Control Board of a right to the use of the water of
FORDYCE CREEK IN NEVADA COUNTY

tributary to SOUTH YUBA RIVER THENCE YUBA RIVER THENCE FEATHER RIVER THENCE
SACRAMENTO RIVER

for the purpose of IRRIGATION, MUNICIPAL AND INDUSTRIAL USES
under Permit 1684 *of the Board and that the right to the use of this water has been perfected*
in accordance with the laws of California, the Regulations of the Board and the permit terms; that the
priority of this right dates from JULY 26, 1923 *and that the amount of water to which*
this right is entitled and hereby confirmed is limited to the amount actually beneficially used for the stated
purposes and shall not exceed TWENTY-SIX THOUSAND SIX HUNDRED SIXTY-TWO (26,662) ACRE-
FEET PER ANNUM, TO BE COLLECTED FROM NOVEMBER 1 OF EACH YEAR TO JUNE 30 OF THE
SUCCEEDING YEAR. THE MAXIMUM WITHDRAWAL IN ANY ONE YEAR SHALL NOT EXCEED
24,573 ACRE-FEET. THE MAXIMUM WITHDRAWAL IN ANY ONE YEAR UNDER THIS LICENSE
AND LICENSE 986 (APPLICATION 2750) SHALL NOT EXCEED 26,572 ACRE-FEET.

LICENSEE HAS HELD 46,662 ACRE-FEET IN STORAGE IN FORDYCE RESERVOIR UNDER THIS
LICENSE AND LICENSE 986 AND CLAIM OF APPROPRIATIVE RIGHT DATED 1873.

THE POINT OF DIVERSION OF SUCH WATER IS LOCATED:

NORTH 36°50' WEST 1,500 FEET FROM SE CORNER OF SECTION 34, T18N, R13E, MDB&M,
BEING WITHIN NE1/4 OF SE1/4 OF SAID SECTION 34.

THE POINTS OF REDIVERSION OF SUCH WATER ARE LOCATED:

- (1) FROM SOUTH YUBA RIVER - AT SPAULDING TUNNEL INTAKE LOCATED NORTH 2°54' EAST
680 FEET FROM 1/4 CORNER COMMON TO SECTIONS 20 AND 21, T17N, R12E, MDB&M,
BEING WITHIN SW1/4 OF NW1/4 OF SAID SECTION 21 AND
- (2) FROM BEAR RIVER - AT BEAR RIVER HEADDAM LOCATED NORTH 41°40' EAST 1,700 FEET
FROM 1/4 CORNER COMMON TO SECTIONS 22 AND 27, T15N, R9E, MDB&M, BEING WITHIN
NW1/4 OF SE1/4 OF SAID SECTION 22.

A DESCRIPTION OF LANDS OR THE PLACE WHERE
SUCH WATER IS PUT TO BENEFICIAL USE IS AS FOLLOWS:

IRRIGATION OF 11,550 ACRES AND MUNICIPAL AND INDUSTRIAL USES ALL WITHIN A GROSS
AREA OF 70,000 ACRES WITHIN ZONE NO. 1 OF PLACER COUNTY WATER AGENCY. THE BOUNDARIES
OF ZONE NO. 1 ARE SHOWN ON MAP TITLED: "MAP OF PLACER COUNTY WATER AGENCY ZONE NO. 1
AND PACIFIC GAS AND ELECTRIC COMPANY. LOWER DRUM DIVISION WATER SYSTEM.
DATED: OCTOBER, 1967." THIS MAP IS ON FILE WITH THE STATE WATER RESOURCES CONTROL
BOARD.

Licensee shall allow representatives of the Board and other parties, as may be authorized from time to time by the Board, reasonable access to project works to determine compliance with the terms of this license.

All rights and privileges under this license including method of diversion, method of use and quantity of water diverted are subject to the continuing authority of the Board in accordance with law and in the interest of the public welfare to prevent waste, unreasonable use, unreasonable method of use or unreasonable method of diversion of said water.

Reports shall be filed promptly by licensee on appropriate forms which will be provided for the purpose from time to time by the Board.

The right hereby confirmed to the diversion and use of water is restricted to the point or points of diversion herein specified and to the lands or place of use herein described.

This license is granted and licensee accepts all rights herein confirmed subject to the following provisions of the Water Code:

Section 1625. Each license shall be in such form and contain such terms as may be prescribed by the Board.

Section 1626. All licenses shall be under the terms and conditions of this division (of the Water Code).

Section 1627. A license shall be effective for such time as the water actually appropriated under it is used for a useful and beneficial purpose in conformity with this division (of the Water Code) but no longer.

Section 1628. Every license shall include the enumeration of conditions therein which in substance shall include all of the provisions of this article and the statement that any appropriator of water to whom a license is issued takes the license subject to the conditions therein expressed.

Section 1629. Every licensee, if he accepts a license does so under the conditions precedent that no value whatsoever in excess of the actual amount paid to the State therefor shall at any time be assigned to or claimed for any license granted or issued under the provisions of this division (of the Water Code), or for any rights granted or acquired under the provisions of this division (of the Water Code), in respect to the regulation by any competent public authority of the services or the price of the services to be rendered by any licensee or by the holder of any rights granted or acquired under the provisions of this division (of the Water Code) or in respect to any valuation for purposes of sale to or purchase, whether through condemnation proceedings or otherwise, by the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State, of the rights and property of any licensee, or the possessor of any rights granted, issued, or acquired under the provisions of this division (of the Water Code).

Section 1630. At any time after the expiration of twenty years after the granting of a license, the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State shall have the right to purchase the works and property occupied and used under the license and the works built or constructed for the enjoyment of the rights granted under the license.

Section 1631. In the event that the State, or any city, city and county, municipal water district, irrigation district, lighting district, or political subdivision of the State so desiring to purchase and the owner of the works and property cannot agree upon the purchase price, the price shall be determined in such manner as is now or may hereafter be provided by law for determining the value of property taken in eminent domain proceedings.
