has made proof as of July 20, 1993 (the date of inspection) to the satisfaction of the State Water Resources Control Board of a right to the use of the waters of an Unnamed Stream in Napa County

tributary to Chiles Creek thence Lake Hennessey thence Conn Creek thence Napa River thence San Pablo Bay

for the purpose of Irrigation, Stockwatering, Recreational, and Fire Protection Uses

under Permit 19326 of the Board and that the right to the use of this water has been perfected in accordance with the laws of California, the Regulations of the Board and the permit terms; that the priority of this right dates from January 26, 1984 and that the amount of water to which this right is entitled and hereby confirmed is limited to the amount actually beneficially used for the stated purposes and shall not exceed a total of twenty-six and five-tenths (26.5) acre-feet per annum to be collected from November 15 of each year to April 30 of the succeeding year as follows: (1) 24 acre-feet per annum in Lake Nancy, and (2) 2.5 acre-feet per annum in an unnamed reservoir. The maximum withdrawal in any one year shall not exceed 15.9 acre-feet from both reservoirs.

The maximum rate of diversion to offstream storage shall not exceed 0.44 cubic foot per second.

This license does not authorize collection of water to storage outside of the specified season to offset evaporation and seepage losses or for any other purpose.

THE POINT OF DIVERSION TO OFFSTREAM STORAGE OF SUCH WATER IS LOCATED:

North 150 feet and East 50 feet from SW corner of projected Section 17, T8N, R4W, MDB&M, being within SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of said Section 17.

THE PLACES OF STORAGE OF SUCH WATERS ARE LOCATED:

Lake Nancy and an unnamed reservoir within NW $\frac{1}{4}$  of NW $\frac{1}{4}$  of projected Section 20, T8N, R4W, MDB&M.

A DESCRIPTION OF THE LANDS OR THE PLACE WHERE SUCH WATER IS PUT TO BENEFICIAL USE IS AS FOLLOWS:

Stockwatering use at troughs within W $\frac{1}{2}$  of SW $\frac{1}{4}$  of projected Section 17 and recreational and fire protection uses at Lake Nancy and an unnamed reservoir within NW $\frac{1}{4}$  of NW $\frac{1}{4}$  of projected Section 20, all within T8N, R4W, MDB&M, and irrigation as follows:

8.5 acres within SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of projected Section 17, T8N, R4W, MDB&M

3.0 acres within NW $\frac{1}{4}$  of NW $\frac{1}{4}$  of projected Section 20, T8N, R4W, MDB&M

11.5 acres total, as shown on map on file with State Water Resources Control Board.

For the protection of fish and wildlife, licensee shall during the period: (a) from November 15 through December 31 bypass a minimum of 0.1 cubic foot per second, and (b) from January 1 through April 30 bypass a minimum of 0.25 cubic foot per second. The total streamflow shall be bypassed whenever it is less than the designated amount.

No water shall be diverted under this license unless licensee has installed a device, satisfactory to the State Water Resources Control Board, which is capable of measuring the flows required by the conditions of this license. Said measuring device shall be properly maintained.

This license is conditioned upon full compliance with Sections 1601, 1603, and/or Section 6100 of the Fish and Game Code.

Licensee shall maintain a pumping and pipeline system of adequate capacity at Lake Nancy in order that water entering the reservoir which is not authorized for appropriation under this license may be released. (0050043)

Licensee shall maintain in Lake Nancy a staff gage, satisfactory to the State Water Resources Control Board, for the purpose of determining water levels in the reservoir. (0050043)

Licensee shall record the staff gage reading on or about November 15 of each year. Such readings shall be supplied to the State Water Resources Control Board with the next Report of Licensee submitted to the Board by licensee.

Licensee shall allow the designated representative of the City of Napa reasonable access to Lake Nancy for the purpose of verifying staff gage readings and determining water levels in the reservoir. (0070047)

Whenever the prior storage right of the City of Napa under Permit 6990 (Application 10990 - Lake Hennessey) is not satisfied by May 1 of any year, licensee shall, upon request by the City of Napa or its designated representative, immediately release from Lake Nancy at the maximum practicable rate an amount of water necessary to satisfy the City of Napa's prior right, up to the total amount of water which licensee has impounded under this license since November 15 of that storage year. In no event shall licensee be obligated to release water below the previous November 15 staff gage reading. Any request by the City of Napa or its designated representative for a release pursuant to this term shall be made on or before May 5. (0000051)

Licensee shall not withdraw for use any surface water impounded in Lake Nancy from November 15 to April 30 of the current storage season until the City of Napa's prior vested right is satisfied. (0430800)

The archeological sites identified as Ca-Nap-219 and CA-Nap-220 in the Cultural Resource survey report for Application 27962 shall not be impacted. No subsurface or surface disturbance of these sites shall occur from either the construction of the proposed reservoir, the installation of the proposed water distribution system, or the cultivation of the place of use. *Licensee shall allow representatives of the State Water Resources Control Board and other parties, as may be authorized from time to time by said Board, reasonable access to project works to determine compliance with the terms of this license.*

*The quantity of water diverted under this license is subject to modification by the Board if, after notice to the licensee and an opportunity for hearing, the Board finds that such modification is necessary to meet water quality objectives in water quality control plans which have been or hereafter may be established or modified pursuant to Division 7 of the Water Code. No action will be taken pursuant to this paragraph unless the Board finds that (1) adequate waste discharge requirements have been prescribed and are in effect with respect to all waste discharges which have any substantial effect upon water quality in the area involved, and (2) the water quality objectives cannot be achieved solely through the control of waste discharges.*

*Pursuant to California Water Code Sections 100 and 275 and the common law public trust doctrine, all rights and privileges under this license, including method of diversion, method of use, and quantity of water diverted, are subject to the continuing authority of the Board in accordance with law and in the interest of the public welfare to protect public trust uses and to prevent waste, unreasonable use, unreasonable method of use or unreasonable method of diversion of said water.*

*This continuing authority of the Board may be exercised by imposing specific requirements over and above those contained in this license with a view to eliminating waste of water and to meeting the reasonable water requirements of licensee without unreasonable draft on the source. Licensee may be required to implement a water conservation plan, features of which may include but not necessarily be limited to: (1) reusing or reclaiming the water allocated; (2) using water reclaimed by another entity instead of all or part of the water allocated; (3) restricting diversions so as to eliminate agricultural tailwater or to reduce return flow; (4) suppressing evaporation losses from water surfaces; (5) controlling phreatophytic growth; and (6) installing, maintaining, and operating efficient water measuring devices to assure compliance with the quantity limitations of this license and to determine accurately water use as against reasonable water requirement for the authorized project. No action will be taken pursuant to this reasonable water requirements for the authorized project. No action will be taken pursuant to this paragraph unless the Board determines, after notice to affected parties and opportunity for hearing, that such specific requirements are physically and financially feasible and are appropriate to the particular situation.*

*The continuing authority of the Board also may be exercised by imposing further limitations on the diversion and use of water by the licensee in order to protect public trust uses. No action will be taken pursuant to this paragraph unless the Board determines, after notice to affected parties and opportunity for hearing, that such action is consistent with California Constitution Article X, Sec. 2; is consistent with the public interest and is necessary to preserve or restore the uses protected by the public trust.*

*Reports shall be filed promptly by licensee on appropriate forms which will be provided for the purpose from time to time by the Board.*

*The right hereby confirmed to the diversion and use of water is restricted to the point or points of diversion herein specified and to the lands or place of use herein described.*

*This license is granted and licensee accepts all rights herein confirmed subject to the following provisions of the Water Code:*

Section 1625. Each license shall be in such form and contain such terms as may be prescribed by the Board.

Section 1626. All licenses shall be under the terms and conditions of this division (of the Water Code).

Section 1627. A license shall be effective for such time as the water actually appropriated under it is used for a useful and beneficial purpose in conformity with this division (of the Water Code) but no longer.

Section 1628. Every license shall include the enumeration of conditions therein which in substance shall include all of the provisions of this article and the statement that any appropriator of water to whom a license is issued takes the license subject to the conditions therein expressed.

Section 1629. Every licensee, if he accepts a license does so under the conditions precedent that no value whatsoever in excess of the actual amount paid to the State therefor shall at any time be assigned to or claimed for any license granted or issued under the provisions of this division (of the Water Code), or for any rights granted or acquired under the provisions of this division (of the Water Code), in respect to the regulation by any competent public authority of the services or the price of the services to be rendered by any licensee or by the holder of any rights granted or acquired under the provisions of this division (of the Water Code) or in respect to any valuation for purposes of sale to or purchase, whether through condemnation proceedings or otherwise, by the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State, of the rights and property of any licensee, or the possessor of any rights granted, issued, or acquired under the provisions of this division (of the Water Code).

Section 1630. At any time after the expiration of twenty years after the granting of a license, the State or any city, city and county, municipal water district, irrigation district, lighting district, or any political subdivision of the State shall have the right to purchase the works and property occupied and used under the license and the works built or constructed for the enjoyment of the rights granted under the license.

Section 1631. In the event that the State, or any city, city and county, municipal water district, irrigation district, lighting district, or political subdivision of the State so desiring to purchase and the owner of the works and property cannot agree upon the purchase price, the price shall be determined in such manner as is now or may hereafter be provided by law for determining the value of property taken in eminent domain proceedings.
